"The greatest of the Flemish sixteenth-century masters of genre was Pieter Bruegel the Elder. We know little of his life except that he had been to Italy, like so many northern artists of his time, and that he lived and worked in Antwerp and Brussels, where he painted most of his pictures in the 1560s, the decade in which the stern Duke of Alva arrived in the Netherlands. The dignity of art and of artists was probably as important to him as it was to Dürer or Cellini, for in one of his splendid drawings he is clearly out to point a contrast between the proud painter and the stupid-looking bespectacled man who fumbles in his purse as he peers over the artist's shoulder.

"The 'kind' of painting on which Bruegel concentrated was scenes from peasant life. He painted peasants merrymaking, feasting, and working, and so people have come to think of him as one of the Flemish peasants. This is a common mistake which we are apt to make about artists. We are often inclined to confuse their work with their person. We think of Dickens as a member of Mr. Pickwick's jolly circle, or of Jules Verne as a daring inventor and traveler. If Bruegel had been a peasant himself he could not have painted them as he did. He certainly was a townsman and his attitude towards the rustic life of the village was very likely similar to that of Shakespeare, for whom Quince the Carpenter and Bottom the Weaver were a species of 'clown'. It was the custom at that time to regard the country yokel as a figure of fun. I do not think that either Shakespeare or Bruegel accepted this custom out of snobbery, but in rustic life human nature was less disguised and covered up with a veneer of artificiality and convention than in the life and manners of the gentlemen [artists such as] Hilliard portrayed. Thus, when they wanted to show up the folly of humankind, playwrights and artists often took low life as their subject."





~~ Blood Donation Chassenge

Caíd Blood Donation Month and "Chassenge 2008"

Díb you know?

- Every two seconds someone in the U.S. needs blood
- More than 38,000 blood donations are needed every day.
- The blood used in an emergency is already on the shelves before the event occurs.
- Most donated red blood cells must be used within 42 days of collection.
- Donated platelets must be used within 5 days of collection — new donations are constantly needed.
- Approximately 60% of the U.S. population is eligible to give blood — only 5% do in a given year.
- AND FINALLY; Shortages of all blood types usually occur during the summer and winter holidays.



hese few facts and many others inspired me to try to make a difference. I realized that the people of the SCA are already willing to give of their time for non-profit support. So I figured, what about their blood – and not just to support a non-profit but to save a life?

After working at the American Red Cross Blood Services Southern California Region for several months, and having already been active in the SCA a few years, I connected the dots and started the Blood Challenge. I really love to help others but so often that help has to come in the form of cash which I don't have. Donating blood allows me to make a difference in the life of at least one person, and possibly three people – without draining my pocketbook! After my first blood donation, though a little uncomfortable, I knew I had made a good decision. I planned to donate every 56 days if I could.

Then a friend explained apheresis donations. Apheresis donations are donations of only blood plasma and platelets. A machine pulls out your blood, separates out the plasma and platelets and then puts your red cells back in your body. Since the red cells are put back

into you, you can donate through apheresis every 14 days! The apheresis process does take a bit longer than whole blood donation*, so if you just can't fit the extra time into your schedule, stick with the whole blood donations.

Now I know it's scary...you know, needles and things...but just imagine you or someone you love needing that blood you are donating. I know when donating through apheresis becomes uncomfortable for me I think of the burn or cancer patients and babies who might need it. I also think of my family members who may one day rely on someone like me who donates regularly for their very lives! Kind of makes it all worthwhile, doesn't it?

* Whole blood donation takes approximately 10-12 mins. When you include check in, medical history and evaluation, donation time and after-donation refreshments, the total whole blood donation time is usually about 1 hr or less. Apheresis donation takes approximately 60-90 mins and the whole donation time can total between 1 $\frac{1}{2}$ and 2 hrs.

Ruses Change on 'SCA-Compatible Names'

ack in the 'Good ole days' of the SCA, standards for documenting names were rather liberal. Before 1991, Elvish names were allowed, as were names from fiction and

mythology. And if you wanted to register 'Kathleen Erin-go-burne-the-Bragh', you could (and somebody did in 1974.) As documentation requirements became more strict, it was noted that there was a pool of names that were rather popular, but had no real evidence that humans ever bore these names before 1600AD. These names were considered to be 'SCA-compatible', and were to be allowed as a concession to modern sensibilities, even if they were not authentic.

In 1994, the College of Heralds was asked whether we should still allow the registering of these names. Back then, the answer was 'Yes.' However, the number of sources for documenting medieval names has been increasing (such as www.s-gabriel.org and heraldry.sca.org), and our knowledge of medieval naming practices has been improving. So, the issue was reopened recently, and the answer is now 'No.'

from the College of Heralds May 2008 Cover Letter:

"Therefore, as of the May 2009 decisions meetings, we declare that no new name elements or name patterns will be ruled SCA-compatible, that all names previously ruled SCA-compatible are no longer SCA-compatible and that in order for them to be registered, documentation meeting the same standards as for non-SCA-compatible names will be required. We note that such evidence has been provided for the following names which used to be SCA-compatible:

❖ "Ian": We have still found no evidence that this name was used in Scotland, but it appears in our period in Dutch as a variant of Jan and in Russian as a form of John. Ian is hence registerable as a Dutch or Russian given name. Note that in both of these cases, the name would be pronounced roughly \YAHN\.

- ❖ "the Wanderer": This is registerable as a Lingua Anglica translation of the attested Polish byname Wandrownyk, in Taszycki, S{I/}ownik Staropolskich Nazw Osobowych, s.n. W{e,}drownik. There is also a documented German surname Wanderer, in Aryanhwy merch Catmael "German Names from Nürnberg, 1497".
- ❖ "-haven" in constructed English place names. When this element was ruled SCA-compatible as a deuterotheme in English place names, the only examples that had been found to that point appended the element Haven to an already existing place name. Since then, examples have been found of -haven used as a genuine deuterotheme, in Whytehauene 1279 and Whithaven 1535 (Watts s.n. Whitehaven), and Kihavene, Kyhavene c.1170-1316 and Kayhaven 1532 (Watts s.n. Keyhaven).
- ❖ "Silver" in order and award names: The August 2005 cover letter says that "orders named for heraldic charges or for items that, while not found in period as heraldic charges, may be used as heraldic charges...may contain the ordinary color names of any heraldic tincture." This includes the use of Silver as the ordinary color name of argent."

(It should be noted that the use of 'Argent' in Altavian award names is a practice grandfathered to the barony, so we're safe.)

~ Guídelines for those who sent in Letters of Intent:

- You must, of course, be and remain a paid SCA member for your entire tenure.
- You must be an active participant in the Barony of Altavia and intend to remain so. You must be able to travel to other areas to represent the Barony as appropriate.
- You need to be familiar with the workings of the SCA, both in our medieval timeframe and within the modern business activities. Having successfully held and performed the duties of a local or Kingdom office is an important qualification.
- You must be able to work with a variety of people having diverse opinions, personalities, and talents. Fairness and impartiality need to be hallmarks of your dealings with others and in the handling of baronial situations. You must consider the effect of potential decisions on the group as a whole as well as individuals, and act accordingly.
- Financial stability is important, as you will incur many expenses. There is no reimbursement for things such as travel and lodging. Kingdom and Corporate regulations also define what expenses may be paid by Baronial funds, and what you will need to bear from your own pocket.
- Consider the effect this position would have on your familial/personal/romantic relationships. If you are a couple, would your duties cause strains? If you are not, would you be able to work effectively with your partner, and would other relationships be affected, and how?

PERSONAL HISTORY OVERVIEWS

on Colwyn Stagghorn's association with the SCA began in the early 1990's, when a group of friends from work told him about this marvelous hobby they had. His first event was an Estrella war where he discovered the magic that the SCA can bring to one's life. From that time on he has been associated with the Household of St. Valentine, a household active mostly at wars and known mainly for their period appearance, love of games and open hospitality. Through his association with this group of friends, he has tried to epitomize the ideals of a true renaissance man, by doing woodworking, metal work, sewing his own garb and building his own pavilion. In recognition of his skills and leadership he was elevated to being a Brother of St Valentine, one of the leaders of the household.

Eventually Colwyn, acting upon his long-standing interest in fencing, began to get involved in rapier by attending the Altavian rapier practices. As his involvement grew, so did his interest in the wider range of activities provided by the SCA. At one time or another Colwyn has been authorized in almost all weapons forms available, from armoured combat to archery to rapier and mostly recently thrown weapons. Colwyn joined a melee squad known as the Third Auxiliary Dragoons, rising through the ranks from soldier to Sergeant then to one of the leaders of the group, a Lieutenant. One of his proudest moments was to be commander upon the field when the Dragoons received the honor of the Crossed Swords at Estrella War in recognition of their prowess and skill as a fighting unit. At Altavian Anniversary 2007, Colwyn was awarded the Vanguard of Honor for his chivalry upon the field. At Great Western War 2007, in recognition of his skill and leadership within the rapier community, Colwyn was invited to become a member of the Order of the White Scarf of Caid, which he proudly accepted.

Don Colwyn is a warranted marshal for rapier. He was the rapier event steward for Great Western XI, where he was responsible for all rapier combat and coordinating with the other stewards and autocrats and the diverse rapier groups. Don Colwyn has been fortunate enough to be able to share the knowledge he has gained at collegiums and at the Known World Academy of Rapier held in Caid in 2006.

Within the Barony of Altavia, Don Colwyn has been the Captain of the guard for the past 3 years and became Rapier Marshal for the Barony of Altavia in 2008. He has assisted in running the melee practices in Angels for the past 5 years

The exiled son of an English noble, Don Colwyn has made his way though the world by virtue of his charm, chivalry, skill of sword and ability to think quickly on his feet. In other words, a courtier with a love of a good story, a good laugh and a good home brew. He is a firm believer in his households motto, "above all else, it must be fun!"

Mundanely, Colwyn is the production manager for a Set and Scenic shop. He coordinates multiple projects for a diverse client base, handling up to 70 employees and 10 different projects under different deadlines.

ady Tezar of Aeolis joined the SCA in March 1980 after going to an event at Glen Helen regional Park in Caid. Immediately smitten with the ideals of the SCA, she became an active member of the Barony of Gyldenholt, where she remained for the next 10 years. Almost immediately Tezar became a member of "The Merrymakers" a period instrumental music performance group. She continued with Merrymakers for 18 years, playing for Coronations, Twelfth Nights, Queens Art Teas, Anniversary tournaments and revels through out the kingdom. Tezar also started doing field & book heraldry, holding the position of deputy herald in Gyldenholt from 1980 to 1982. She continues to do heraldry whenever possible, on the field, for court and helping others design their arms. In 1986 she spent 6 months as Gyldenholt List Mistress.

Throughout the 1980's Tezar and her family were immersed in SCA activities, going to events through out the kingdom; children's activities, assisting newcomers with garb, active in costuming, cross-stitch, calligraphy and illumination. She also co-autocrated a Baronial anniversary tournament during this time. She has participated in arts & science competitions in the fields of music, drawing and illumination, winning and receiving notice for several entries. Tezar and her family were members of the Drafyn War band for many years, helping organize cooking for the encampment at wars and assisting the younger members to make garb and build pavilions. With her ex-husband, Tezar helped transport the Royal Trailer during the first reign of Dietrich and Deshive and was involved in the construction of Thrones and other royal regalia.

In 1991 Tezar and her family moved to the Kings Lands of Frazier Park. While there she helped start and autocrat a weekend event known as "The Household Wars". This event ran annually from 1993 through 1996.

In 1997 Tezar left Frazier Park, moving to the Barony of Altavia then to the Barony of Angels in 2000. She became involved with the Household of Saint Valentine, becoming a full member in 2002. She spent 2 years as deputy field herald for the Barony of Angels and as a member of the baronial court before joining her husband on the Altavian court in 2005. In 2007 she became court herald for the Barony of Altavia, a position she still holds.

Tezar became involved in the rapier community starting in 1999, becoming a warranted rapier marshal in 2003. She has been an active supporting person for the rapier community since that time.

In 2007 Tezar founded a college branch of the SCA at California State University at Northridge. She is President/Seneschal of The Medieval and Renaissance Society at CSUN and the incipient College of Saint Firmin, submitted to the College of Heralds in 2008.

Tezar continues to enjoy spending time with the friends she has met at the many events and wars she has attended through out Caid and other kingdoms in the past 28 years.

Tezar of Aeolis is the daughter of a Greek Merchants daughter and French merchant seaman. She grew up in the south of France, moving to England with her marriage to a Welshman. Upon her first husbands' death under a collapsed siege machine, Tezar supported her children teaching and tending local noblemen's children and selling baked goods. With her remarriage she is enjoying a chance to teach her own children and work on clothing and baked goods for her own family.

Mundanely, Tezar has been a safety inspector for the insurance industry for the past 30 years. She is getting her BA in Psychology at California State University, Northridge in May 2009 and looks forward to starting a new career in Social Work shortly thereafter.

Diversity is what makes this Barony feel so alive. Altavians do it all Heavy Weapons, Weaving, Dancing, Rapier, Thrown Weapons, Singing, and everything in between -- this Barony has talent! We love this aspect of the Barony and will work to ensure that everyone, of every disposition, feels welcome in Altavia.
- ~ Attend events. Altavia has always traveled to other Baronial events as often as possible. The Barony has a reputation throughout Caid for courtesy and gregariousness when traveling, as well as for being very hospitable within our borders. We plan to sustain the strong presence within this Kingdom the Barony currently has by attending as many events (near and far) as possible, expecting our level of commitment to be two to three events per month, minimum.
- \sim And lastly, we hope to keep Altavia a place of joy, friendship, and honor. We will always treasure and support this wondrous Barony, and would be honored and humbled to serve as the next Baron and Baroness.





The Mythes of Pentathson

nce upon a time, in a galaxy far far away......no wait...wrong time period. Let me start again...Once upon a time in AS XII, when Caid was a young Kingdom, a group of people decided that an event should be

created foster to excellence in the Arts Sciences in this Kingdom. Thus was born the Caid Arts and Faire Sciences and Pentathlon. they thought and then told me some more. The moral is, be careful what you ask for...you just might get it.

However, in listening to what everyone had to say, I realized that there were a few misconceptions that I felt needed addressing. Caid Arts and Sciences Faire and Pentathlon, most commonly referred to as "Pentathlon" is a most interesting Kingdom Level Event. I do not think any other Kingdom event engenders such strong feelings, both positive and negative, and anxiety,

outside of possibly Crown Tournament. However, when you think about it, it really is not surprising. A Heavy Weapons Fighter will practice tirelessly for months and even years in order to reach a level where he feels confident

enough to enter Crown.

artisans, and please note as far as I am concerned, anyone who enters the Caid Arts Sciences Faire and Pentathlon, is artisan, pour hearts and souls into the research crafting of their works of art for months and years as well before taking that leap of faith and entering "Pentathlon." It's no wonder people feel so strongly about this event! You are not only displaying what vou wrought but you are asking for a group of people (i.e., the judges) to tell

However, I believe I digress. My intent here is to clear misconceptions and hopefully allay the fears of those who have never entered. I would also like to say here and now that my staff and I are committed to do all that is possible to make this event as "user friendly" as possible. To that end...let us address the most prominent and persistent Pentathlon Mythes.

you what they think of what you did.

All who enter are to be applauded and

commended.

Mythe #1: I need to make at least 5 items in order to participate!

Let me assure you that this is most persistent mythe is most certainly *NOT* TRUE! Please recall, what I said above, this event came into being as a vehicle to foster the Arts and Sciences in Caid. Hence why it is called the Caid Arts and Sciences Faire and Pentathlon! Populace and the Judges want to see what you've made! Really! So please note, you only need to enter a minimum of 5 items if you are participating in the "Pentathlon" portion of the event. Otherwise, you can enter one or two items in any category(ies) of your choice. Of course for our more prolific artisans you can enter up to 10 items in no less than 4 categories and increase your chances at becoming the Pentathlon champion as your five highest scores over 4 categories will be used. And trust me I know people who do just that!!!

Mythe #2: A Novice will never win Pentathlon (or Only Laurel's win) so why should I enter?

Let me tell you that the reason you should enter is because absolutely, categorically, unequivocally In fact, based on my own BUNK! personal search of the Order of Precedence, in the entire history of the Caid Arts and Sciences Fair and Pentathlon a Laurel has won only 3 times. And just to further debunk this mythe, may I add that the last two Arts and Sciences Pentathlon Champions have been novices, that is, first time entrants. Caid Arts and Sciences Faire and Pentathlon actually has a "Novice Prize" awarded to the high scoring first time enterant, which has not been awarded the past two competitions because the highest scoring "Novice"

has won Pentathlon! Truth be told, anyone can become the Arts and Sciences Pentathlon Champion and there is added incentive this time around as the next Pentathlon Champion will also become the Kingdom Arts and Sciences Champion.





Mythe #3: The Judging is skewed so only an Artisan will win Pentathlon!

This is basically Mythe #2 with a twist and also not true. Please know that all entries to the Caid Arts and Sciences Faire and Pentathlon are judged against "the ideal" and not against each other. So you are a journeyman brewer and have brewed a basic honev mead and there are 7 other honey meads in your category. You are <u>not</u> in competition against the other 6 honey meads, rather you are being judged against what the "ideal" mead should This means that there could be. potentially be more than 1 mead that high scores in the journeyman honey mead category and win. You will not be judged against the artisans nor will the novices be judged against you. Each of you will be judged against what is the ideal in your level.

Mythe #4: My documentation needs to practically be a doctoral dissertation!

This is most certainly also not true, if for no other reason than because the judges do not have the time to read doctoral theses the day the items are judged. However, by the same token this is true if you are entering the "Research Paper" category and even that does not need to be a thesis either. And for all intents and purposes your research paper itself is your Please refer to the documentation. General Rules for Pentathlon for the rules governing Research Papers and documentation for futher clarification. If you are unclear, please, please feel free to email me and I will do my best to clarify any confusion you may still have. We are currently working on

providing clearer information about what your documentation should contain, please check the Pentathlon website under the Kingdom A&S Page for further information.

#5:

The Judges are mean and out to get me! (or some variation thereof)

Let me assure you that this is most certainly untrue! Please know that the judges, like you, are artisans themselves and understand the artisan soul. After having spoken to several past judges, I find that judges take their responsibilities very seriously and many times agonize over the feedback they give the entrants. They want to give constructive information where needed to help you with your chosen art. They really are not there to beat you down to a pulp. This benefits no one. They are there as volunteers because they want to see what beautiful things you have made. They are there to be "WOWed" so get out there and WOW them!!!

Mythe #6: I can make one item and enter it in two categories.

Unfortunately, this is also untrue. example, let us say your cups of tea are costuming and tablet weaving. Both of these "classes" fall under the category "Fiber Arts." Now you have hand sewn this 12th Century T-tunic and you have decorated it with tablet weaving vou have hand woven yourself. So you think, heck I can kill two birds with one stone! Sorry no can You will have to decide whether do. you are going to enter that really spiff T-tunic under "Costume Construction" or Weaving: Tablet or Card weaving. Now what you can do is enter that spiffy T-tunic and enter it under Costume Construction and then separately weave a lovely piece of tablet weaving and enter it under Weaving: Tablet or Card Weaving. This is not a problem. Please note that we do not do this to be meanies, but because we just do not have the volunteers to run items back and forth from the different judging areas. Also, scheduling the judging to work around entries that could need to be in two places at once would a logistical nightmare.

Mythe #7: I can bring my item(s) on the day of the event and enter.

Unfortunately, yet again, no you may not! There is a reason why we have a pre-registration deadline. You are taking the time to craft your entries **and** we are in turn trying to schedule the best qualified judges to judge your entry and give **you** adequate feedback.

For example, you send in your preregistration and tell the Entry Steward that you are entering the following items:

- Level: Apprentice Category: Visual Arts Class: Illumination – Item: Illuminated Scroll.
- Level: Journeyman Category: Culinary Arts -Class: Brewing - Item: Raspberry Vinegar
- Level: Journeyman Category: Performance Arts – Class: Vocal Performance – Item: Cantiga from the Cantigas de Santa Maria
- Level: Artisan Category: Fiber Arts Class: Costume Construction – Item: 13th Century Spanish Pellote
- Level: Artisan Category: Fiber Arts Class: Hats - Item: 13th Century Spanish Toque

While you are working putting the finishing touches to your entries above and your supporting documentation, the Entry Steward is adding all your items to her ever growing list of entries broken down by categories and classes which in turn is forwarded to the Judging Steward as soon as possible. Please also keep in mind that a good 80% of entry preregistrations arrive within days of the deadline. Then the real fun starts. The Entry Steward forwards her lovely list to the Judging Steward and thanks God she didn't volunteer for that job!!! It is then the Judging steward's job to 1) Rue the day she said yes to me and 2) Schedule judges to judge all the items entered in the Caid Arts and Sciences Faire and Pentathlon. Needless to sav not only do we have talented artisans entering but we also have multitalented artisans judging! So the Judge autocrat has to make it so Mistress Multitalentosa is able to judge the Illumination class and Hats...oh forgot...she's yeah...we knowledgeable in Paper making and we have a few entries in there and oh

yeah...we forgot, her **L**aurel is in dyeing so we gotta make sure she can judge that class too....you get the idea. Oh yeah, did I mention she has to also coordinate so that Master Knowitall who is judging 3 categories of his own is scheduled so that he can judge the Illumination class at the same time as Mistress Multitalentosa? Without the invaluable information provided to us in the pre-registration in advance, judging would be a logistical nightmare. believe that my Judging Steward would actually disagree and say that the scheduling is a logistical nightmare and had she been of sound mind, would have run in the opposite direction when she saw me coming!)

Mythe #8: I can enter an item I have entered before if I've fixed what was wrong.

Sorry, but no. That

would be considered

double dipping. Whatever you choose to enter must have been <u>completed</u> between one Caid Arts and Sciences Faire and Pentathlon and the other. It does not matter that you may have been working on your recreation of the Bayeux Tapestry for the past 15 years. You just need have finished it <u>after</u> the last Pentathlon and not ever have entered any element of it in a previous Caid Arts and Sciences Fair and Pentathlon.

Mythe #9: I can have help with my Pentathlon entry.

Well, yes and no. Clear as mud? Thought so. Let me see if I can successfully clarify this. If your entry is handspun wool, you have to have spun that wool yourself. Your Laurel, Mistress Ima Spinner cannot help you

in any way to produce the wool you are spinning as your entry. She can critique what you have spun and advise what you can do to improve it, but you must do the work yourself. Now, let us say that you are also working on your documentation and you are the world's worst speller bar none! Then it would acceptable have Master to Spellwright review your documentation for spelling errors and point them out to you. However, your documentation has to be completely your own words and your own work. The point of this event is not to drive you crazy. The point is to further foster your love of spinning and in researching how wool was spun in period, better educate you in the subject you love so that you can then educate others and "enable" future spinners.

Mythe #10: Entries are "bumped up" so that they can't win!


Wrong again! Let me assure you again that the judges are not "out to get you!" If you get bumped up a category, then it is because the judges believe you are <u>that good</u> and you are only going to get bumped if you are going to be awarded in the category you are being bumped into! Again, please remember that the express intent and purpose of the Caid Arts and Sciences Faire and Pentathlon is to encourage and foster the Arts and Sciences.

I could go on forever dispelling mythes but then this article itself would become the doctoral thesis no one and the Kinadom wants to read Chronicler would never accept submission from me....ever! So I think I will guit while I am ahead. I hope that I have helped dispel some mythes and reduce any reluctance entering the Caid Arts and Sciences Faire and Pentathlon. WE do not care whether you are a Brewing Laurel or someone who just started to sing 16th Century Turkish love songs. come out and share with us what you can do. Allow us to enjoy the beauty you have wrought. What we most want all who read this article to understand is that we are all 100% committed to making this event as "user friendly" as If you have questions, please, please do not hesitate to contact me at CaidPentathlon (AT)gmail.com. 

3.25.0: Vocal Performance (Performance of selection of pre-1650 vocal or new composition in pre-1650 style. Provide 3 copies of the music for the judges. Ten minute maximum.)

3.26.0: Instrumental Performance (Performance of a selection of pre-1650 instrumental or new composition in pre-1650 style. Provide 3 copies of the music for the judges. Ten minute maximum.)

3.27.0: Court Dance (Performance of a pre-1650 court dance or a new composition of a court dance in pre-1650 style. Use garb appropriate for region and period of dance. Entrants must provide their own accompaniment.

Ten minute maximum.)

3.28.0: Country Dance

(Performance of a pre-1650 country dance or a new composition of a country dance in pre-1650 style. Use garb appropriate for region and period of dance. Entrants must provide their own accompaniment. Ten minute maximum.)

3.29.0: Ethnic Dance
(Performance of a pre-1650 ethnic dance or a new composition of an ethnic dance in pre-1650 style.
Use garb appropriate for region and period of dance.
Entrants must provide their own accompaniment.
Ten minute maximum.)

3.30.0: Persona Presentation (Entrants will be given a 15-minute time slot in which the judges will interact with them and ask questions about their persona. Entrants will be judged on overall effectiveness, ability to stay in persona, knowledge of their period, and other criteria. Props are optional, but if included, should be authentic and documented. Persona presented must be from a pre-1650 culture and must be clearly designated on the entry form. Documentation is required and must be submitted to the Entries Autocrat by the pre-registration deadline. Documentation cannot be a first person re-telling of the persona story; it must instead be documentation of the period and culture from which the persona comes from, with an emphasis on the activities of daily life.)

3.31.0: Performance Art other:

Entries that do not fit in pervious categories. A descrption of the performance must submitted at the time of entry and must be a form of performance type or style from a pre-1650 culture.

4.32.0: Costume (Men and Women) (You must enter a specific section, not just "class 31." If needed, sections will be broken down into the following time periods: pre-1300, 1300-1499, 1500-1650.)


